2. Financial Upgradation under MACPS shall be purely personal to the official and shall have no relevance to ones seniority position. As such, there shall be no additional financial upgradation for the senior employee on the ground that the junior employee in the grade has got higher pay / Grade pay under MACPS.

3. The pay shall be raised by one increment in the existing Level before placing in the upgraded Level of Pay Matrix.

4. The financial benefit granted above under the MACP Scheme shall be final and the pay fixation benefit shall not accrue at the time of regular promotion in the higher grade.

5. On the grant of financial upgradation under the Scheme, there shall be no change in the designation, classification on higher status. While fixing pay and giving MACPS benefit, it may please be ensured that all Rules are followed scrupulously.

6. The concerned Officials should furnish an undertaking declaring that no Criminal / Court case is pending against him / her.

7. The grant of financial upgradation will be subject to any court decision, which may have a bearing on this order.
